DECLARATION OF PECUNIARY INTERESTS FORM

I, DEAN RICHARDS hereby declare the following pecuniary interests:

NB. 'your partner' means your spouse/civil partner or someone you are living with as husband and wife or as civil partners.

Employment, office, trade, profession or Vocation:

Any employment, office, trade, profession or vocation carried on for profit or gain by you or your partner.

SELF EMPLOYED WORKING IN THE FIELD OF FINANCE AND DATA ANALYTICS

Sponsorship: Any payment or provision of any other financial benefit (other than from Cawston Parish Council) made or provided within the 12 months before this declaration in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

Contracts: Any contract which is made between you or your partner (or a firm or body corporate in which you or your partner is a partner or a director, or in the securities of which you or your partner has a beneficial interest) **and** Cawston Parish Council —

(a) under which goods or services are to be provided or works are to be executed; **and**
(b) which has not been fully discharged.

"Director" includes a member of the committee of management of an industrial and provident society;

Land: Any beneficial interest in land which is within the area of Cawston Parish and which gives you or your partner a right to occupy the land or receive income.

HOME OWNER IN CAWSTON WHERE I RESIDE

Licences: Any licence held by you or your partner (alone or jointly with others) to occupy land within Cawston Parish for a month or longer.

Corporate Tenancies: Any tenancy where (to your knowledge)—

(a) the landlord is Cawston Parish Council; **and**

(b) the tenant is a body in which you or your partner has a beneficial interest, i.e. a firm or body corporate in which you or your partner is a partner or a director,
or in the securities of which you or your partner has a beneficial interest.

NONE

Securities: Any beneficial interest held by you or your partner in securities of a body where—

(a) that body (to your knowledge) has a place of business or land in the area of Cawston Parish Council; **and**

(b) either—

(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; **or**

(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest which exceeds one hundredth of the total issued share capital of that class.

"Securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
